Mule-Hide HD-15 Fasteners (Extra Heavy Duty) are # 15 fasteners manufactured from C-1022 Phillips Cold Heading Wire. The fastener has a No. 3 Phillips recess, flat truss head. The drill point tip is of a double flute, self-drilling design for faster penetration into the roof deck.

Mule-Hide's HD-15 Fasteners (Extra Heavy Duty) are designed specifically for the mechanical attachment of the Mule-Hide Reinforced EPDM, PVC and TPO membranes in steel, wood and concrete decks.
